The interface is organized so that the solution-level content appears first, followed by the information for each network component. The solution information acts as a guide to the component-based information, which can be accessed through the solution-level information or directly from the interface.

Solution and component-level information is organized into seven functional areas:

- Configuration
- Accounting
- Performance management
- Security and admin
